**Snow Removal Agreement and Release of Liability**  
**Snow Removal Policy 3200-01**

By signing this agreement, I request that the Village of Innisfree (together with its employees, agents or contractors referred to as the “Village”) perform snow removal services (the “Service”) on my property, at the address set forth below.

I agree, personally on my own behalf, and on behalf of any other person whose property is damaged while on my property, to release and waive any claims or causes of action for property damage caused by the Village while providing the Services.

I further agree to hold harmless and indemnify and hold the Village harmless against any and all claims resulting from such Services including, without limitation, claims of property damage to my property or the property of any other person which is damaged while such property is located on my property.

The Village’s “Snow Removal Policy” is on the reverse side of this page.

**NOTE:** *Property Owners who have specific needs or requirements with respect to snow removal (e.g. timing of snow removal) may desire to have such services provided by persons or entities other than the Village.*

## OUTLINE OF VILLAGE SNOW REMOVAL POLICY

### General:

1. The Village will commence snow removal on municipal roads if there is:
  - a. three inches of snow accumulation on Village roads. The Village Public Works Foreman may commence snow removal upon approval of the C.A.O. on weekends or non-regular hours.
  
2. Priority for plowing roads with a heavy snowfall shall be as follows:
  - a. Fire Hall area
  
  - b. School bus drop-off and pick up area
  
  - c. Main Streets (50<sup>th</sup> Avenue from Railway Avenue to 53 Street and 51<sup>st</sup> Street from Railway Avenue to 49<sup>th</sup> Avenue.)
  
  - d. Residential and back alleys, starting with the two major south side streets that are on the hill (51<sup>st</sup> and 52<sup>nd</sup> Street)
  
  - e. The Landfill/Waste Transfer Station access road
  
  - f. Back alleys only become a priority when the snowfall does not allow emergency vehicle access or garbage vehicle access.
  
  - g. Snow removal on driveways is the responsibility of Residents/Ratepayers unless a Liability waiver has been signed and a request for clearance submitted to the Village Office.**

**\*The removal of snow from driveways will not be considered a priority.**
